Credit Agreement and Export Compliance Agreement

Credit Agreement

We hereby agree to the terms of sale listed on each Advanced Link invoice. In case of a credit sale, we agree that Advanced Link may charge a financing fee of one and one-half percent per each thirty-day period, or part thereof, for any invoice that is past due. We understand that if any part of the Company's account becomes past due, then the entire account, regardless of any terms to the contrary, shall become due and payable immediately. If the bank returns a Company check, the Company will be assessed \$70.00 for each check. We understand if any amount due Advanced Link is collected through an attorney or collection agency, all collection expenses will be added to the amount due to Advanced Link. In order to induce Advanced Link to extend credit for the purchases of Advanced Link's products and for other good and valuable consideration, we hereby convey, grant and transfer to Advanced Link a purchase money security interest in the products and all proceeds until we perform all our obligations due to Advanced Link. If, at any time, Advanced Link, believes such security interest to be insufficient or if it deems itself insecure, we agree that all obligations shall become immediately due and payable; and we further agree that Advanced Link, may collect payment of all obligations, through any negotiable instruments in its possession or otherwise, without demand or notice. If we are a proprietorship, partnership, or personal guarantor we authorize Advanced Link to order a consumer credit report in connection with the review of existing and future extension of credit. We agree that our transactions with Advanced Link shall be governed by and construed in accordance with the laws of the State of California. We further agree that any lawsuit or arbitration between Advanced Link and ourselves shall be brought only in the state or federal courts of Orange County, California. We understand that at Advanced Link's sole option, any controversy or claim arising out of, or relating to, this Agreement, or the breach thereof, may be settled by binding arbitration in accordance with the California Arbitration Law and administrated by the American Arbitration Association under its commercial arbitration rules.

Export Compliance Agreement

You may not export or re-export any products sold by Advanced Link in violation of any applicable laws or regulations.

Without limiting the generality of the foregoing, hardware, software, technology or services provided under this agreement may not be exported, re-exported, transferred or downloaded to or within (or to a national resident of) countries under U.S. economic embargo including the following countries: Balkans, Belarus, Burma, Cuba, Iran, Liberia, North Korea, Sudan Syria and Zimbabwe. This list is subject to change.

Hardware, software, technology or services may not be exported, re-exported, transferred or downloaded to persons or entities listed on the U.S. Department of Commerce Denied Persons List, Entity List of proliferation concern or on any U.S. Treasury Department Designated Nationals exclusion list, or to parties directly or indirectly involved in the development or production of nuclear, chemical, biological weapons or in missile technology programs as specified in the U.S. Export Administration Regulations (15 CFR 744).
